

# FRIENDS OF RYE HARBOUR 833 LOTTERY CLUB - TERMS & CONDITIONS



## 1. The Club

- a. The name of The Club is “**The 833 Lottery Club**”.
- b. The sole purpose of The Club is to raise funds to support the development and on- going management of the Rye Harbour Nature Reserve Discovery Centre. To this end 60% of the annual fees for Membership and additional Lottery Numbers will be retained by The Club, the remaining 40% will be made available for lottery prizes (Prize Pot).
- c. The Club is operated under the Friends of Rye Harbour Nature Reserve Small Society Lottery Licence no. LN/000024102.

## 2. Membership of The Club

- a. Any person may apply to be a member of The Club with the following exceptions:
  - Those under 16 years of age
  - Members of the Friends of Rye Harbour Nature Reserve Committee
  - The Administrators of The Club
- b. Members will pay an annual subscription by either standing order, bank transfer, cheque or cash. The cost of subscription will be set at £24. This subscription will entitle the Member to one lottery number. The cost of each additional number purchased will be £24.
- c. Members will be invited to renew their membership on the anniversary of their joining month.

## 3. Lottery Numbers

- a. The maximum of Lottery Numbers available for the lottery draw is 833
- b. Lottery Numbers will be allocated by the administrators of The Club and upon renewal of membership will stay with the Club Member
- c. Lottery Numbers will not be allocated until the annual subscription has been cleared into The Club bank account
- d. Lottery Numbers that become free after a Club Member does not renew will be available for re-allocation to other Club Members

## 4. Lottery Draw

- a. There will be one lottery draw per month. The lottery draw will usually take place on the 2nd Saturday of every month at the Rye Harbour Nature Reserve Discovery in the presence of at least one independent witness
- b. Under exceptional circumstances the lottery draw may take place at another location, as agreed from time to time by the administrators of The Club in conjunction with The Friends of Rye Harbour Nature Reserve Committee. This location may be remote from the independent witness, and if so live video streaming technology will be used to ensure that the independent witness is able to observe the draw.
- c. The draw will be taken from all allocated Lottery Numbers
- d. Three Lottery Numbers will be drawn each month.

## 5. Lottery Prizes

- a. The amount available for prizes each month will be one twelfth of the Prize Pot (the Monthly Prize Pot).
- b. The first prize will be 60% of the Monthly Prize Pot, the second prize will be 25% of the Monthly Prize Pot, and the third prize will be 15% of the Monthly Prize Pot. For example, if 500 Lottery Numbers have been allocated the Monthly Prize Pot will be £400 [this being  $((500 \times £24) \times 40\%) / 12$ ] and of this the first prize will be £240, the second prize will be £100 and the third prize will be £60.
- c. The winners of the Lottery Draw will be notified in writing and payment of prizes will be by cheque.
- d. The Lottery Numbers drawn will be published at the location of the Lottery Draw, on the Friends of Rye Harbour Nature Reserve website and related social media pages, and at other locations as determined from time to time by the Friends of Rye Harbour Nature Reserve.

## 6. Disputes

- a. In the case of a dispute, this must first be raised with the administrators of The Club. If the parties are unable to resolve the dispute, then The Friends of Rye Harbour Nature Reserve will be the final arbiters and their decision will be binding

## 7. Changes to these Terms & Conditions

- a. The Friends of Rye Harbour Nature Reserve reserve the right to amend or revoke these Terms & Conditions at their absolute discretion, and those changes considered material will be notified to the Members on a timely basis
- b. The Terms & Conditions will be re-issued to members of The Club with renewal reminder notices

## 8. Termination

- a. The Club can be terminated at any time by The Friends of Rye Harbour Nature Reserve
- b. Upon termination all members will receive, by cheque, any outstanding balances of their annual subscription
